"That '70s 'Vette: Just Another Girly Car?..."

By the mid-1970s, the Corvette was just a pretty skin with a weak engine.

BY the time "Invasion of the Body Snatchers" arrived in movie theaters in 1978, it was clear that something evil had been sucking the mechanical soul out of sleek-skinned Corvettes for several years.

The third-generation Corvette made its debut as a 1968 model, based on the same mechanicals as the 1963-67 car, but with a new, outrageously styled body. It would become the longest-running Corvette body style, remaining in production through 1982, though undergoing extensive updates during this time. Over its long run, the C3, as enthusiasts refer to the entire run, would reach both the apex and nadir of Corvette performance.

The peak came early. In 1969, Chevrolet offered the most powerful Corvette to date, the ZL1. This was an optional engine package with an all-aluminum, 427-cubic-inch, big-block V-8. Listed at 430 horsepower, the engine's true output has been reported at more than 550. Only two ZL1 Corvettes were built, as the steep price of the option (\$4,718.35) nearly doubled that of the car itself.

Things went downhill quickly, as G.M. began detuning its high-performing V-8s in 1971, reducing the compression ratio so they would run on unleaded gasoline. Then, in 1972, the auto industry changed the way it reported horsepower, switching from gross horsepower to a net measurement that took into account losses from necessities like the alternator and water pump. Advertised horsepower dropped, even when there were no mechanical changes.

As you can see, this Corvette has been modified and not just with a set of custom wheels and a set of valve covers. It wears custom paint and pin stripping, plus fender flairs. I'd say it's also safe to assume the hood and side pipes are also add-ons. For the most part, I'm alright with the looks, but I'm not sure about the quality of the work or how it's held up after being in storage. The paint will need to be redone, the top needs replaced and the wheels either need new paint or to be replaced with something more original. And during paint prep, you might want to remove the spoiler mounts and tow

hitch!

Now for the real scary custom work! Have a look at those seat covers! I hope the faux fur seat covers and door treatments aren't glued down, but I have a feeling the are. What would inspire someone to attach this material to their Corvette's interior? I know it was the '70s, but even leopard print fabric would have looked better than fur! I guess you'll have to redo the interior anyway. On the upside, this car has a 3rd pedal and a 4 speed shifter! It should make putting all 370 horses produced by the LT1 to good use a bit more enjoyable! So why do you suppose this Corvette was parked after only a few years of use?



The Sting Ray Revolution: C2 Corvette (1963 – 1967)

The second generation, or <u>C2 Corvette</u>, launched in 1963 with a total design overhaul inspired by the Sting Ray race car. This generation introduced the first-ever Corvette Coupe and the unique split rear window, a feature exclusive to the 1963 model. The C2 also saw the introduction of Big Block V8 engines in 1965, generating up to 425 horsepower, which significantly boosted the Corvette's performance capabilities.

By 1967, the C2 Corvette had incorporated several safety features, such as an energy-absorbing steering column, hazard lights, and a dual master cylinder brake system. These innovations not only enhanced the car's performance but also its safety, further cementing its reputation as a top-tier sports car.

The Birth of an Icon: C1 Corvette (1953 – 1962)

The Chevrolet Corvette made its debut as a concept "dream car" at the 1953 General Motors Motorama show in New York. This sleek, performance-focused vehicle quickly won the hearts of American drivers. The first generation, known as the <u>C1 Corvette</u>, was initially hand-built at GM's Flint, MI factory, with the first 300 units released to the public on June 30, 1953.

In 1954, production moved to St. Louis, MO, where the Corvette continued to evolve. By 1956, the Corvette had undergone significant redesigns, including exposed headlights, rolled-up windows, and sculpted side coves.

The introduction of a removable hardtop also marked a significant milestone. From 1960 to 1962, the Corvette featured rounded rear fenders, integrated taillights, and a bold grille with heavy "teeth," solidifying its iconic look.
